
Publisher Open Access Agreements

Existing publishing agreements give UR members who act as corresponding authors the opportunity to publish certain types of articles in certain journals free of charge or for a discounted open access fee.

For the assignment of manuscripts to the UR, please refer to the “Conditions” tab above and the publisher-specific stipulations in this document.

Where publication is not free of charge, this also applies to articles from publishing agreements: Funding from the Publication Fund is possible for pure (in [DOAJ](#)-listed) OA journals up to €2000 (in 2025/2026) if the above “conditions” are met. In most cases, the invoice is sent directly to the university library, which automatically checks for eligibility. Any remaining costs will be transferred to a cost center of the corresponding author.

American Association for the Advancement of Science (AAAS):

Science Advances (fully OA journal): 2020-2026 15% discount on APCs (meaning \$4,632.50 in 2026 instead of the list price APC of \$5,450). To do this, open the "Apply Discounts" field in the CCC RightsLink payment portal under "charges" and "total due" and select the UR there.

UR funding: If the OA publication costs exceed our subsidy or the journal is not listed in [DOAJ](#), the corresponding author will be billed internally by the university.

American Physiological Society (APS):

The library will support the publisher's Subscribe to Open model from 2025, so there will be no OA fees for UR authors (and for all other authors if there is sufficient support).

Association for Computing Machinery (ACM):

hybrid journals: 2021-2026 free OA publication in all "APC-eligible publications" (also includes certain conference proceedings). This list and workflow instructions are available to the library. Publisher e-mails to authorized authors. (use university email-domain!) You can find authorized article types [here](#).

American Chemical Society (ACS):

Acceptance date from 2024 to 2026: Neither the university nor the corresponding author will be charged OA publication fees for articles in hybrid journals and also in ACS Omega, ACS Central Science, ACS Au family. There may be waivers for the other 5 fully OA journals, see <https://acsopenscience.org/customers/bbws-consortium/>. The eligible article types vary from journal to journal. The main affiliation of the submitting corresponding author at the time of submission is the determining factor. Information to eligible submitting corresponding authors is provided by the publisher. African Studies and International Development-Kollektion:

The University Library of Regensburg supports the financing of the e-book package "African Studies and International Development Collection" by Bloomsbury in 2025, so that selected titles can be freely accessible without author and reader fees.

American Society for Microbiology (ASM):

The library supports the publisher's Subscribe to Open model for 2025-2028, meaning that individual volumes of the six S2O journals Antimicrobial Agents and Chemotherapy, Applied and Environmental Microbiology, Infection and Immunity, Journal of Bacteriology, Journal of Clinical Microbiology, and Journal of Virology can be made open access with sufficient additional support, without authors incurring OA fees (APCs).

Even if there are not enough additional participants and a volume is therefore not made OA, UR members will still have access to read it. In addition, articles by corresponding authors from UR will still be made open access.

However, ASM generally applies page charges and supplemental material fees regardless of this. Corresponding UR authors receive a 25% discount on these fees, see <https://journals.asm.org/publication-fees> (prices applicable to us: "S2O subscribing rates"). Further discounts are available with a personal membership: <https://asm.org/membership>. These fees are not subsidized by the publication fund.

Annual Reviews:

The library supports the publisher's Subscribe to Open model, so that individual journal volumes can be made open access without incurring author fees if there is sufficient additional support.

Biochemical Society Journals - Portland Press:

2025-2026: The library supports the publisher's Subscribe to Open model, so that individual journal volumes can be made open access without incurring author fees if sufficient additional support is provided.

Specifically, this agreement applies to our researchers: "Free and unlimited publication services (= OA articles under CC-BY license) for Corresponding Authors, regardless of whether the respective journal is published in Open Access in the respective year or not." The following applies to fully OA journals: "Free and unlimited publication services for corresponding authors included."

BMJ British Medical Journals

extended until the end of 2026:

hybrid journals: free OA publishing of "original research articles" in the standard journal collection (does not include "The BMJ"). The acceptance date is determining.

pure OA journals: 15% discount on APCs (as long as there is credit on our deposit. The costs will be deducted from our deposit, then charged uni-internally if the grant is exceeded or the journal is not listed in [DOAJ](#)).

Cambridge Journals Online

2022-2026: articles in hybrid and pure OA journals free of charge and unlimited. This means that neither the university nor the author is charged OA publication fees. Page charges do not apply to OA publications.

Possible article types: research articles, review articles, rapid communications, brief reports, case reports. Only few journals do not yet offer the OA option. However, from 2025 onwards, some journals will only allow open access for "research content" (see <https://www.cambridge.org/core/services/open-research/open-access-journal-flips>). Publisher information/eligible journals, etc. can be found under "Eligibility checker" at <https://www.cambridge.org/core/eligibility-checker#wiversProductDataInner>.

Company of Biologists

2024-2026: free OA publication of research articles in the 3 hybrid and the 2 pure OA journals (Five-journal package) of the non-for-profit-publisher. See author assistance at <https://www.biologists.com/library-hub/read-publish/guide-for-authors/>.

De Gruyter

agreement on ebooks: The Regensburg University Library supports the financing of an e-book package from the field of history (from 2024) and Millennium Studies (2023-26) so that selected titles can be freely accessible without author and reader fees.

agreement on journals: 2023-2025:

Submission with UR email address required.

pure OA journals:

- 20% discount on APCs. Eligible authors will be notified of the agreed discount and billed accordingly.
- UR funding: If the OA publication costs exceed our subsidy or the journal is not listed at <https://doaj.org/>, the corresponding author will be billed internally by the university.
- Pure OA journals are journals from the list <https://www.degruyter.com/cms/pages/ejournals?lang=de> that have "APC" listed in the "publishing model" column. The offer also extends to journals from the publisher that are converted to OA or founded as OA journals during the term of the agreement.

hybrid journals:

- Free OA option in certain economics journals (see link above).
- In addition to research articles, other types of articles such as book reviews are also covered by the agreement. The date of acceptance is decisive. Eligible authors will be identified and notified by the publisher.
- In the current 6 journals in which OA publication is not possible, authors from authorized institutions are entitled, at no additional cost, to deposit their articles published in the licensed journals in the form published by the publisher immediately after publication and without embargo in an (institutional, discipline-specific, non-commercial) repository of their choice immediately after publication and without embargo, thus making them accessible in OA.

Additionally:

The library supports the publisher's Subscribe to Open model, which means that individual volumes of journals marked "S2O" can be made open access if sufficient additional support is provided, without authors having to pay fees. If the threshold is not reached, none of the articles will be made open access. The publisher also refers to its secondary publication policy <https://www.degruyterbrill.com/publishing/fuer-autoren/fuer-journal-autoren/sharing-your-work>.

Elsevier

Change effective from submission date September 1, 2025: **Author share per publication also applies to hybrid journals – regardless of OA!** See above for details!

Publisher-specific criteria for assigning the article to the UR (resulting in centralized processing, OA option in hybrid journals at no additional cost, discounted fees in pure OA journals):

- submitting corresponding author is crucial (see also tab "Conditions")
- articles accepted in 2025/2026 (possibly extended until 2028)
- included journals: Cell Press and Lancet-Journals; An overview of the titles included and not included can be found [here](#). Cell Press and The Lancet journals are marked there (currently in column "bucket") with "CP/TL hybrid" and "CP/TL Gold" accordingly.
- article types: all article types that are subject to peer review and for which Elsevier charges an OA fee (Labels: Full Length Articles; Review Articles; Case Reports; Data in Brief; Microarticle; Original Software Publication; Protocol; Replication Study; Short Communication; Short Survey; Video Article); no support of submission/colour charges etc.

Further Information:

- Fully-OA-Journals: 20% discount on list prices of Elsevier Fully Gold Open Access-journals ("Core Gold") and 15% discount on list prices of Fully Gold Cell Press and The Lancet-journals („CP/TL Gold").
- If the publication fee (plus VAT) exceeds our subsidy (in 2026: 2000€), we ask the corresponding author to indicate a cost center after receipt of the collective invoice - which will only be issued a few months after publication for fully OA journals. For hybrid journals we ask directly after acceptance.
- The publication fee charged by Elsevier changes annually and depends on the date of acceptance for hybrid journals and the date of submission for fully OA journals.
- Please note that the university will be charged for assigned articles under this agreement even if you decide against OA in the hybrid journals. Therefore, you should definitely use the OA option! We recommend the CC-BY license.

- Procedure: After acceptance and link from the publisher, the submitting corresponding author indicates in the author portal where the publication originated. If necessary, select "University (hospital) Regensburg" instead of Institute xy, otherwise the DEAL assignment may be missing. If the institution, journal and article type are DEAL-eligible, the reference to DEAL, the central invoice processing and the possible partial or full assumption of costs by the institution will now appear in the section "publishing options". Emerald

2026: hybrid journals: free OA publication in journals included in our bundle „Management eJournal Portfolio“ (journal list can be accessed via University Library). Valid for all article types. Acceptance date is decisive.

Procedure: The UR must be selected from a drop-down menu upon submission and, as usual, must be listed as the first/primary affiliation in the article. Eligible corresponding authors will be identified upon acceptance of their article based on their institution's Ringgold-ID (UR: 9147, UKR: 39070) or their institutional email domain. They will be informed about the agreement and then given the opportunity to redeem a voucher for their OA publication. (For screenshots please reach out to us.)

EMS Journals

The library supports the publisher's Subscribe to Open model so that individual journal volumes can be made open access without incurring author fees if there is sufficient additional support. In 2024/2025, this will be the case for all 22 Subscribe to Open journals. Together with the 4 Diamond OA journals, the entire EMS Press journal portfolio will therefore be Open Access in 2024/2025.

Frontiers

pure OA journals: From submission date 01.08.2023: 10% discount on APCs.

In the payment process, select "Choose payer: Frontiers institutional members: Universität Regensburg" (instead of "individual payer") in the publishing portal.

UR funding: If the OA publication costs exceed our subsidy or the journal is not listed at <https://doaj.org/>, the corresponding author will be billed internally by the university.

Hindawi

Hindawi was acquired by Wiley in 2022. Thus, these publication fees will be charged in a later DEAL total invoice with the UB and then internally with the researchers.

20% discount on APCs except for the following journals: Australian Journal of Grape and Wine Research, Genetics Research, Global Health, Epidemiology and Genomics, Journal of Smoking Cessation, Laser and Particle Beams, Wireless Power Transfer, Mental Illness, Advanced Gut & Microbiome Research, Adsorption Science & Technology, International Journal of Distributed Sensor Networks, Journal of the Renin-Angiotensin-Aldosterone System, Molecular Imaging.

Only one Corresponding Author is possible. This eligible author must submit and correctly select the affiliation.

UR funding: If the OA publication costs exceed our subsidy or the journal is not listed at <https://doaj.org/>, the corresponding author will be billed internally by the university.

Hogrefe: PsyJournals

2024-2026: hybrid journals: free OA publication of research papers

pure OA journals: 25 % discount on APCs. For more information see [FAQs](#). UR funding: If the OA publication costs exceed our subsidy or the journal is not listed at <https://doaj.org/>, the corresponding author will be billed internally by the university.

2022-2025: unlimited free publication opportunity of all "research article types" (including "research papers", "special issue articles", "letters" and "review articles") in hybrid and pure OA journals (title list: <https://tib.eu/cloud/s/R6ytqHw72BeJmXp> and <https://tib.eu/cloud/s/98xG3KS7BPeR9W3>). ECS journals are not included. Neither the university nor the author is charged OA publication fees (page charges etc. remain unaffected).

Note: unlike other publishers, IOP recommends that you check "Open Access Choice? No" in the submission process for hybrid journals, so that the author does not have to pay personally if the article is not eligible for free OA. The publisher will contact all eligible authors (if the 1st affiliation of the corresponding author is UR/UKR!). The authors then only have to sign the Open Access copyright form.

Acceptance date in 2024-2026: The library supports the publisher's Subscribe to Open model, so that individual journal volumes can be made open access without incurring author fees if there is sufficient additional support.

hybrid journals: Terms for free OA option:

- Article types: case report, data report, meta-analysis, methods article, research article, review article, systematic review (not relevant: abstract, article commentary, book review, brief report, correction, discussion, editorial, guideline, introduction, letter, meeting report, news, obituary, other, reply, retraction)
- Karger Compass journals do not include relevant article types for hybrid publishing
- Invited articles may become freely accessible anyway (but without CC licenses). An additional OA position is usually also possible for the author free of charge, but causes costs for the University Library.

University Library of Regensburg supports project [Koala](#) financially, so that periodicals in the field of media and social sciences (2023-2028), mathematics and computer science (2024-2026) and quantum physics (2024-2026) can be published open access without author fees.

Mathematical Sciences Publishers (MSP)

The library supports the Subscribe to Open model of the publisher 2025, so that individual volumes of certain journals can be made OA with sufficient additional participation and no OA fees are incurred for UR authors.

MDPI

from 2025: 30 % discount on APCs

UR funding: If the OA publication costs exceed our subsidy or the journal is not listed at <https://doaj.org/>, the corresponding author will be billed internally by the university.

(please note: several MDPI journals are no longer included in DOAJ and therefore no longer eligible for funding from the publication fund.)

Microbiology Society

2025-2026: free OA publication in the hybrid journals (Journal of General Virology, Journal of Medical Microbiology, International Journal of Systematic and Evolutionary Microbiology) and the pure OA journals (Microbial Genomics, Microbiology) as well as on the research platform (Access Microbiology) of the non-profit publisher. Submission with UR e-mail address required!

Nature

2025: In addition to the DEAL agreement with Springer Nature, which excludes “nature branded” journals (journals with “Nature” in the title), the UR 2025 is participating in the “Nature Journals” agreement.

Here, Corresponding Authors of participating institutions can publish free of charge in the journal “Nature” and in the hybrid Nature-branded research journals under a CC-BY license. Eligible journals are marked with a “Y” in the “Nature OA Publishing” column in the [list](#): “Reviews journals” and ‘Nature Protocols’ are excluded. All “Research Articles” are covered, i.e. articles of the type: OriginalPaper, Analysis, Article, Letter, Brief Communication, Registered Report, Resource and Technical Reports.

Open Book Publishers

The non-profit platform OBP publishes OA monographs of the humanities and is also financially supported by the University Library in 2026 for this purpose. It therefore offers discounts to customers with an UR IP address on the parallel print versions, which are subject to a fee. In addition, the EPUB formats can also be downloaded free of charge with an UR IP address. There will still be fees for publishing.

Open Library Economics - OLEcon

The University Library supports the “Open Library Economics – OLEcon” initiative, which enables certain journals (<https://olecon.zbw.eu/en/supported-journals>) in economics and business management to be published in open access without charging reader or author fees.

Open Library of Humanities

The OLH non-for-profit-platform publishes publications of the humanities in its approximately 30 OA journals without author or reader fees and is also financially supported by University Library for this purpose.

PNAS

hybrid journals: 2025-2026 discounted APCs for immediate OA option. Otherwise the item will be OA after 6 months when paying minor fees. For reference: <https://www.pnas.org/author-center/publication-charges>.

Rockefeller University Press

hybrid journals: 2024-2026 free OA option in Journal of Cell Biology (JCB), Journal of Experimental Medicine (JEM) und Journal of General Physiology (JGP).

SAGE

hybrid journals:

2021-2026 (date of acceptance decisive): free OA option for corresponding authors of UR in most Sage journals (we have the "Premier (complete) package"). Exceptions include journals in the "Royal Society of Medicine (RSM)" and "Institution of Mechanical Engineers (IMechE)" packages, as well as the Mary Ann Liebert imprint (journal lists available via UBR).

Eligible document types: original research papers, review papers, brief communications, short reports, and case reports.

If the article is eligible, SAGE will indicate this after acceptance.

Fully OA journals:

2021-2026 20% discount (automatic based on institutional affiliation. Individual journals, especially Mary Ann Liebert, are excluded from the discount.)

UR funding: If the OA publication costs exceed our subsidy or the journal is not listed in <https://doaj.org/>, the corresponding author will be billed internally by the university.

The University Library of Regensburg supports the scientific publication platform SciPost financially, because it stands for "real" Open Access: non profit, neither author nor reader fees, copyrights remain with the authors, academic editing, open infrastructure, open access, open finances, open citations.

Scoap3

The Regensburg University Library financially supports the journals of the Scoap3 project so that they can be published open access without author fees.

Change effective from submission date September 1, 2025: **Author share per publication also applies to hybrid journals – regardless of OA!** See above for details!

Publisher-specific criteria for assigning the article to the UR (resulting in centralized processing, OA option in hybrid journals at no additional cost, discounted fees in pure OA journals).

Hybrid journals:

- Only for journals under the Springer brand, not for journals under the Nature brand.
- Articles accepted in 2020-23 and from 2024 onwards
- Article Types: Original Papers, Review Papers, Brief Communications, Editorial Notes, Book Reviews, Letters, Reports (in specialty journals, only research articles submitted without prior invitation - i.e., original paper, review paper, brief communication - are accepted)
- no acceptance of color charges etc.
- After the article has been accepted by the publisher, the corresponding author fills out the "publishing and rights" declaration in the author portal. To check whether the APCs displayed can be assigned to an institution, the main affiliation must be selected. Important for the assignment to DEAL or the UR is at this point the selection of the University of Regensburg/the University Hospital Regensburg from the drop-down menu there (no manual entry!)
If the institution, journal, and article type are DEAL-eligible, a note will now appear in a green box referring to DEAL, the central invoice processing system, and the possible partial or full coverage of costs by the institution.
- A fixed publication fee is payable for each article in hybrid Springer/Wiley/Elsevier journals that is assigned to the UR. For submissions from September 1, 2025, fees exceeding €2,000 will be passed on to researchers within the university. See above for details. Important: These publication fees apply to every article assigned to us, regardless of OA! We therefore strongly recommend continuing to choose the open access option (CC-BY license) so that the articles are freely accessible and reusable for everyone!
Articles classified by Springer as "non-research" (editorial notes, letters, book reviews, reports) are exempt from the publication fee. Under the DEAL agreement, neither the university nor the author incurs any costs for these articles.
- If there is no indication of DEAL, no showing of the green box, and instead you are shown costs, the full amount would be payable by you personally. In these cases, please feel free to contact oa@ur.de or/and oa.verification@springernature.com beforehand. If you are unsure, we will gladly send you screenshots.

pure OA journals:

- This includes journals distributed under BioMed Central
- Article Types: Research Articles (= Original Paper, Review Paper, Brief Communication)
- Discount 20% on Springer and BioMedCentral APCs - except for Scientific Reports and Nature Communications. The respective (smaller) discounts for Nature-branded journals are given in the [journal list](#). (Date for APC pricing: Acceptance date)
- When submitting, you will be asked for the "payment method". The option "... believe that I am covered by a Springer Nature Open Access Agreement" should be selected here. After acceptance of the article, the University of Regensburg/University Hospital Regensburg must be searched for and selected under "Verify your affiliation" in the author portal. If the institution, journal and article type are DEAL-eligible, the reference to DEAL, the central invoice processing and the possible partial or complete coverage of the costs by the institution will now appear.
- UR funding: If the OA publication costs exceed our subsidy or the journal is not listed in <https://doaj.org/>, the corresponding author will be billed internally by the university after receipt of the collective invoice, which will only be issued several months after publication.

The UBR supports this model financially in the fields of media studies (from 2022) and political science (in 2025), as selected books will be made available in open access.

Wiley

Essential: The "responsible corresponding author" must be a member of the University of Regensburg!

Change effective from submission date September 1, 2025: **Author share per publication also applies to hybrid journals – regardless of OA!** See above for details!

Publisher-specific criteria for assigning the article to the UR (resulting in centralized processing, OA option in hybrid journals at no additional cost, discounted fees in pure OA journals).

Hybrid journals:

- Articles accepted in 2019-2023 and from 2024 onwards
- Article types: "primary research articles" and "review articles" (not "editorial pieces" such as "letters" or "book reviews")
- No acceptance of color/page charges etc.
- If the article is eligible, after selecting the UR/UKR in the "affiliations" drop-down menu, a note will appear referring to DEAL, central invoice processing, and the possible partial or full coverage of costs by the institution. You should then select "Yes, make my article open access" instead of "Keep my article subscription-only."
- A fixed publication fee is payable for each article in hybrid Springer/Wiley/Elsevier journals that is assigned to the UR. For submissions from September 1, 2025, fees exceeding €2,000 will be allocated internally to the researchers. See above for details. The classification of Wiley journals according to "tiers" and the publication costs can be found in the [price list](#)—currently in column L (€2,200 → Tier 1; €2,700 → Tier 2; €3,150 → Tier 3). Important: These publication fees apply to every article assigned to us, regardless of OA! We therefore strongly recommend continuing to choose the open access option (CC-BY license) so that the articles are freely accessible and reusable for everyone!
If there is no reference to DEAL and you are instead shown costs, these would be payable in full by you personally.

pure OA journals:

- Discount of 20% on the APCs, see [Price List](#). (Date for APC pricing: Acceptance date)
- When submitting, select the option "My institution or funder has an agreement with Wiley and may pay the Article processing charges" in the "who will pay" section of the Author Portal.
- UR funding: If the OA publication costs exceed our subsidy or the journal is not listed in <https://doaj.org/>, the corresponding author will be billed internally by the university after receipt of the collective invoice, which will only be issued several months after publication.
